



# ROYAL FREMANTLE GOLF CLUB INC AND GOLDFIELDS GOLF CLUB INC

## RECIPROCAL PLAYING RIGHTS AGREEMENT 2014

### 1. ELIGIBILITY

- (a) A visiting member must be a Full and Financial Member of the Reciprocal Club.
- (b) A visiting member is not entitled to privileges greater than those of the home club.
- (c) No person living permanently within 65 kilometres of the Host Club shall be eligible as a Visiting Reciprocal Member.

### 2. INTRODUCTION

- (a) A visiting member must be able to provide the Host Club a current valid membership card of the Reciprocal Club.
- (b) A visiting member is to contact the Golf Operations Manager at Royal Fremantle Golf Club in advance of the dates they wish to play.
- (c) Prior to or on arrival, a visiting member must produce a letter of introduction signed by their General Manager/Golf Manager including the member's current handicap.

### 3. USAGE OF FACILITIES

- (a) A visiting member may play on the course a maximum of five (5) times per calendar year not including Saturdays.
- (b) A visiting member using the Club's facilities, does so without paying green fees, however the competition fee is payable.
- (c) A visiting member must observe the dress code of rules and etiquette of the Host Club.
- (d) A visiting member is entitled to enter competitions but cannot win principal Club events, perpetual trophy events, monthly medals and other events deemed inappropriate by the General Manager.
- (e) A visiting member may introduce up to three (3) guests on a non-competition day and guests are required to pay the standard guest fees.
- (f) A visiting member's rights to play on the course will be limited to the playing rights of the member at his/her home club.

### 4. TERMS OF RECIPROCAL RIGHTS

- (a) The Terms and Conditions herein stated may, with mutual agreement, be reviewed from time to time.
- (b) This agreement may be cancelled by either club giving one month's notice in writing to the other club.

### **Reciprocal Playing Right Agreement Goldfields Golf Club & Royal Fremantle Golf Club Inc**

1. Each of the undersigned clubs shall extend to any visiting full member of the other club all the privileges to the golf course and other club facilities afforded to its own members. Absentee and overseas members are not permitted to use reciprocal rights.
2. The above mentioned privileges will be exclusive of the regular fee usually charged to visitors and for a maximum of 6 days in any calendar year. Any additional rounds above this limit will be charged the standard visitors rate.
3. Reciprocal members must produce an introductory card or letter upon arrival, which is to include category of membership as well as current handicap. It is also preferable that a letter be forwarded by the reciprocal member's club in advance advising of the impending visit.
4. Reciprocal members shall be subject to all rules, bylaws and other controls in affect at the time of their visit.
5. All purchases for meals, drinks, etc must be paid for in cash/credit card or eftpos.
6. Each reciprocal member shall have the same rights to introduce guests as a member of the host club (subject to course availability) and such visitors shall pay the normal green fee applicable to a guest playing with a member.
7. Reciprocal members and guests will be allowed access to the club competitions at the discretion of the Club Captain. Their eligibility to win trophies will also be at the Captain's discretion and they shall be informed of this prior to tee-off.
8. A member of the reciprocal club residing temporarily in Kalgoorlie for more than one month or on a permanent basis is not entitled to reciprocal privileges beyond the first month of residency.
9. This agreement shall remain in force until such time as either Club, or the 'City of Kalgoorlie Boulder' (being the owner of the Kalgoorlie Golf Course), upon written notice terminates the agreement giving 3 months notice
